## Terms and Conditions

You must read these Terms and Conditions in full. In accepting a grant from Australian Lions Hearing Dogs, it is understood that you have read and agree to comply with these Terms and Conditions.

Please note, if you are under 18 years of age, your parent or guardian must read and consent to these Terms and Conditions on your behalf.

Successful grant applicants will receive a letter of offer which details the grant benefits and payment timeline. If you do not wish to accept a grant you are offered, you should advise us immediately in writing.

By submitting this grant application you confirm your understanding of the following conditions;

- You understand that you cannot claim against Australian Lions Hearing Dogs for any damage or injury incurred as a result of this grant.
- You understand that Australian Lions Hearing Dogs reserves the right to withdraw the grant and their support at any time should the applicant fail to comply with Australian Lions Hearing Dogs guidelines.
- You understand that Australian Lions Hearing Dogs, its staff and volunteers cannot be held responsible for any loss or damage that occurs as a direct or indirect result of the grant.
- You confirm that you are in a suitable physical and mental condition to undertake what the grant is intended for and have considered and taken measures to mitigate any risk that may be associated.

Upon acceptance of a grant offer from Australian Lions Hearing Dogs you agree to;

- Make every effort to uphold the good name and character of Australian Lions Hearing Dogs;
- Acknowledge the support of Australian Lions Hearing Dogs in a positive light;
- Not claim, or imply, that you speak on behalf of Australian Lions Hearing Dogs or that your views are representative of Australian Lions Hearing Dogs;
- Seek the authorisation of Australian Lions Hearing dogs before using our brands or logos in any form
- Not undertake any activities that are unlawful
- Conduct your grant activities in accordance with these guidelines
- Act in good faith with Australian Lions Hearing dogs.

Australian Lions Hearing Dogs may terminate your grant if we deem that you have

- Represented any part of Australian Lions Hearing Dogs in a negative or misleading way;
- Failed to meet the eligibility requirements of your grant;
- Failed to meet the grant terms and conditions;
- Failed to under the uses outlined in your application to a level deemed satisfactory by Australian Lions Hearing Dogs;
- Failed to undertake the uses outlined in your application within the agreed timeframe;
- Been made an incorrect grant offer as determined by Australian Lions Hearing dogs at its sole discretion; and/or
- Have provided incorrect, false or misleading information or withheld relevant information on your grant application or after receiving a grant offer.

If your grant is terminated, you will not receive any further payment. You may be required to repay some or all of your grant.

At the end of the grant duration specified in your grant application you will be asked to provide a report detailing how the grant funds have been spent. It is the responsibility of the grant recipient to provide this report tot Australian Lions Hearing dogs by the specified time. Failure to return reports by the specified time may result in a request for return of the funds provided.

You will also need to repay the grant if:

- The payment is made to you in error or you have been overpaid;
- Your grant is terminated;
- You do not meet the conditions of the grant or are deemed to be ineligible for the grant.

In the event that you are required to repay your grant, you must do so within 4 weeks of receiving the notification.

If you are offered a grant, your details including name, photograph, video and grant awarded may be passed on to media and used by Australian Lions Hearing Dogs and/or partner organisations for promotional purposes, including but not limited to the Australian Lions Hearing Dogs website, social media channels, print and electronic media.

It is agreed that the use of these photographs and videos shall in no way be used in any other forum other than official Australian Lions Hearing Dogs business. The grant recipient also waives the right to inspect or approve the finished product, the advertising copy or other matter that may be used in connection therewith or the use to which it may be applied.
